**Travis Glaser, Supervisory Special Agent**: Travis Glaser has been a Supervisory Special Agent since September 2015, Special Agent since July 2001. Prior to becoming a special agent, I was an auditor with McGladrey & Pullen and Ernst & Young in Kansas City.
