- Your application is received by the deadline.
- You would like to earn the Enrolled Agent (EA) designation.
- If you successfully complete Parts I, II & III E.A. Exam Review Course offered by NATP.

Scholarships will be awarded based on a point system that will include chapter involvement, community involvement, educational background and work history within the tax professional community.
